

## PROLINE / SportAction Transformation Contest Conditions

### Qualified Entrant and Entry

1. A “**Qualified Entrant**” is a British Columbia resident 19 years of age or older who is not a:
  - a) BCLC employee, consultant or contractor;
  - b) BCLC “Lottery Site Employee” as defined in the BCLC Retailer Policy Manual;
  - c) family or household member of (a) or (b) residing at the same address;
  - d) participant in BCLC’s Game Break Program; or
  - e) banned or barred from a casino or community gaming centre or by BCLC.
2. The “**Contest Period**” will run from July 15, 2024, at 12:01 am PT to September 30, 2024, at 11:59 pm PT.
3. To obtain a “**Qualified Entry**”, a Qualified Entrant must, during the Contest Period:
  - a) go to [www.bclc.com/proline](http://www.bclc.com/proline) (the “**Entry Form**”);
  - b) navigate to the ‘Enter to Win’ tab
  - c) answer the question listed in the Entry Form; and
  - d) complete and submit the Entry Form.
4. No purchase is necessary to participate in this contest.
5. BCLC is not responsible for any entry, or transmission of the entry that is incorrect, omitted, illegible, late, lost, delayed, garbled, destroyed, misdirected or not recorded due to failure(s) or error(s) for any reason of the entrant, internet, internet provider(s) or any computer(s).
6. A Qualified Entry must be received by BCLC before the end of the Contest Period to be eligible to win a Prize.

### Prize

- v. one (1) \$250 food & beverage credit at Parq Vancouver; and
  - vi. one (1) \$250 free play credit at Parq Vancouver.
9. Each Winner may only win a maximum of one (1) Prize.

  11. Each Grand Prize has a total value of approximately \$5,000.
  12. While the Game is currently scheduled to take place on November 9, 2024, the date of the Game is subject to change. The section, row, and seat numbers for the Game Tickets will be preassigned and may not be selected by the Winner.
  13. To receive the free play credits at Parq Vancouver, the Winner must be an Encore Rewards member.
  14. The Grand Prize Winner and their guest are solely responsible for:

**Draw**

The Drawn Entrant will be deemed a Winner when BCLC confirms the Drawn Entrant meets these contest conditions.

19. BCLC will attempt to contact each Drawn Entrant using the contact information provided by the Drawn Entrant in the Entry Form. If, despite BCLC's reasonable efforts, BCLC is unable to contact a Drawn Entrant or the Drawn Entrant does not respond within three (3) days from the time BCLC contacted the Drawn Entrant, and fails to provide valid government issued photo ID to BCLC for verification thereof and to complete the prize release form, that Drawn Entrant will be disqualified, and another Qualified Entrant will be drawn, and become the Drawn Entrant for that Prize.
