

RUSH Playoffs Bet Back Conditions

- 1. To participate in this Saskatchewan RUSH Playoffs Bet Back Promotion (the "**Promotion**") you must:
 - a. be a Saskatchewan resident and be nineteen (19) years of age or older; and
 - b. have an active PlayNow.com account.
- 2. This Promotion starts on April 19, 2025, at 00:00:00 am PT / 01:00:00 am CST and ends on May 31, 2025, at 21:59:59 pm PT / 22:59:59 pm CST (the "Promotional Period").
- 3. To receive up to \$20 bonus bet ("**Sports Bonus Bet**") under this Promotion, you must complete these steps ("**Steps**") in the following order:
 - a. Log into your PlayNow.com account;
 - b. Enter promo code "RUSHPLAYOFFS"; and
 - c. Make a single wager, a minimum of \$5 to maximum of \$20, on any National Lacrosse League game during the Promotional Period ("**NLL Wager**").*
- 4. Once the Steps are completed, a Sports Bonus Bet will be added to your PlayNow.com account, matching the value of your wager, to a maximum of \$20 (for example, if you place a \$10 wager, you will receive a \$10 Sports Bonus Bet).
