### RUSH Playoffs Casino Bonus Conditions

1. To participate in this Saskatchewan RUSH Playoffs Casino Bonus Promotion (the “**Promotion**”) you must:
  - a. be a Saskatchewan resident and be 19 years of age or older,
  - b. have an active PlayNow.com account.
2. This Promotion starts on **April 20, 2026 at 12:00:00 AM PDT / 1:00:00 AM CST** and ends on **May 31, 2026 at 11:59:59 PM PDT / June 1, 2026 at 12:59:59 AM CST** (the “**Promotional Period**”).
3. To receive a \$20 Casino Bonus under this Promotion, you must complete these steps in the following order during the Promotion Period:
  - a. Log into your PlayNow.com account; and
  - b. Enter promo code “**ROWDY20**”; and
  - c. Make a minimum deposit of \$5 into your PlayNow.com account; and
  - d. Make a single sports wager totalling \$5 or more on any sport on PlayNow.com.
  - e. A \$20 Casino Bonus will be added to your account.
  - f. The Casino Bonus awarded from this Promotion has a five (5) times Wagering Requirement applied to them.

#### Wagering Requirement Rules
