
UFC Canadian KO Offer Conditions

1. To participate in this UFC Fight “Canadian KO Bonus” promotion (the “**Promotion**”), you must be a resident of British Columbia or Saskatchewan 19 years of age or older, or a resident of Manitoba 18 years of age or older.
2. The Promotion will be available from **April 15, 2026 at 12:00:00 am PT / 2:00:00 am CST** and ends on **April 18, 2026 when the Main Event, last fight of the night, begins at approximately 5:00:00 pm PT / 8:00:00 pm CST** (the “**Promotional Period**”).
3. To receive a \$20 sports Bonus Bet token (“**Sports Bonus Bet**”) under this Promotion, you must complete the following steps in order:
 - a. register for an account on PlayNow.com or log into your PlayNow.com account;
 - b. Place a minimum \$20 or more single wager on any Canadian fighter in the UFC Winnipeg event on one of the following eligible markets: (“**a Qualifying Wager**”).
 - i. *Fight Winner*
 - ii. *3-Way Fight Winner (Fighter A wins/Fighter B wins/ Draw)*
 - c. The Canadian fighter that you pick must be one of the following Canadian fighters scheduled to complete at UFC Winnipeg event:
 - i. Mike Malott
 - ii. Charles Jourdian
 - iii. Mandel Nallo
 - iv. Jasmine Jasudavicius
 - v. Julien Leblanc
 - vi. Tanner Boser
 - vii. Melissa Croden
 - viii. Jamey-Lyn Horth
 - ix. Jamie Siraj
 - d. Your selected Canadian fighter must lose by KO or Submission.
(“Eligible Wager”);
4. You will receive a \$20 Sports Bonus Bet when you meet all conditions of an eligible wager.

Example: If you wager \$20 on Mike Mallot to win (Fight Winner or 3-Way Fight Winner Markets) and Mike Mallot loses by **KO or Submission**, you will receive a \$20 Sports Bonus Bet.

5. This Promotion only applies to the first Eligible Wager per player, per fight during the Promotional Period. Scheduled fights for the day can be found [“here”](#).
6. A promotional code is not required for this Promotion.
7. Both Winnings and losing bets will qualify but only the results (Canadian fighter losing by KO or Submission) determine the eligibility for the Sports Bonus Bet.
8. Standard parlays, combo bets, or SGP (Same Game Parlay) bets do not qualify for this Promotion.
9. Tokens from other promotions, bonus funds, or other credits cannot be used to meet the wagering requirement for this Promotion.
10. A Sports Bonus Bet will be awarded within 72 hours of settlement
11. A Sports Bonus Bet awarded through this Promotion may be redeemed only once.
12. Players can qualify for a maximum of one (1) Sports Bonus Bet per fight.
13. Bets that are cashed out do not qualify for this Promotion.
14. A Sports Bonus Bet awarded through this Promotion is subject to the following conditions:
 - a. A Sports Bonus Bet can only be used for wagering on PlayNow.com Sports bets; and
 - b. The entire value of a Sports Bonus Bet must be used on a single bet or parlay bet within a single transaction on the bet slip. It is not possible to use a Sports Bonus Bet across multiple bets on your bet slip.
15. A Sports Bonus Bet awarded through the Promotion expires 14 days after being awarded. An expired Sports Bonus Bet will not be reissued following expiration.
16. Wagers placed using a Sports Bonus Bet do not qualify for any other promotion on PlayNow.com.
17. A Sports Bonus Bet must be accepted as awarded and cannot be exchanged for cash.
18. British Columbia Lottery Corporation (“**BCLC**”), Saskatchewan Indian Gaming Authority in conjunction with BCLC (“**SIGA**”), and Manitoba Liquor and Lotteries Corporation in conjunction with BCLC (“**MBLL**”), reserve the right, in their discretion, to adjust or cancel any Sports Bonus Bet for any reason including if awarded in error.
19. BCLC, SIGA, and MBLL, reserve the right to disqualify players that do not comply with these conditions, the Player Agreement, or other applicable Rules or Terms of Use

(each as defined in the Player Agreement, collectively the “**Lottery Rules**”). In the event of a conflict between these conditions and any lottery scheme, the applicable Lottery Rules will prevail.

20. In the event PlayNow determines a player is misusing, exploiting, or manipulating any sportsbook promotion or bonus system, PlayNow reserves the right to revoke any player’s eligibility for current and future promotions.
21. This Promotion and the use of tokens are subject to the PlayNow.com Player Agreement.
22. See the PlayNow.com Player Agreement for terms and conditions applicable to tokens.
23. This Promotion may be withdrawn, extended, or amended by BCLC, SIGA, or MBLL, at any time.
24. All stated dollar amounts are in Canadian funds.
25. If validation of your PlayNow.com account is pending, the Sports Bonus Bet will be deposited when your PlayNow.com account is validated providing all conditions have been met.
26. If you are having difficulty entering this Promotion, you must contact Customer Support with error issues while the Promotion is *still* valid. Any inquiries after the Promotional Period has lapsed will not be considered as eligible for a Sports Bonus Bet.
27. By participating in this promotion, you agree to save and hold BCLC, SIGA in conjunction with BCLC, and MBLL in conjunction with BCLC, harmless from and against any and all actions, claims or demands by you (including costs incurred by BCLC, SIGA, and MBLL in defending such actions, claims or demands) brought against BCLC, SIGA, and MBLL, which arise out of or are in any way connected to this promotion.
28. All decisions of BCLC, SIGA, or MBLL, are final and binding.
