

Definitions

- 1. **BCLC** means British Columbia Lottery Corporation.
- 2. **SIGA** means Saskatchewan Indian Gaming Authority.
- 3. SaskGaming means Saskatchewan Gaming Corporation.
- 4. **Drawn Entrant** means an individual whose name is drawn to win a Prize as a result of the Prize Draw.
- 5. **Prize Winner(s)** means the Drawn Entrant or Reserve Drawn Entrant who fulfills these Contest Conditions
- 6. **Reserve Drawn Entrant** means an individual whose name is drawn as a backup as a result of the Prize Draw and who becomes a Qualified Entrant in the event that the original Drawn Entrant becomes disqualified.

Contest Period

7. This contest (the "Contest") runs from 00:00:00 am PT on Monday, October 16, 2023 to 23:59:59 pm PT on Sunday, November 5, 2023 in British Columbia, and 1:00:00 am CST on Wednesday, November 15, 2023 to 11:59:59 pm CST on Wednesday, December 6, 2023 in Saskatchewan (the "Contest Period") and will be subject to these contest conditions (the "Contest Conditions").

Qualified Entrant

- 8. A qualified entrant ("Qualified Entrant") means:
 - a) a British Columbia resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not a:
 - BCLC employee; or
 - family or household member of a BCLC employee, or
 - b) a Saskatchewan resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not:
 - a SIGA or SaskGaming employee; or
 - an immediate family member of a SIGA or SaskGaming employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee;
 - c) provided that:
 - individuals who are currently self-excluded or who self-exclude at any time during the Contest Period from PlayNow.com are not Qualified Entrants and are not eligible to win a Prize; and
 - individuals that are currently barred or are barred at any time during the Contest Period from PlayNow.com, or a British Columbia or Saskatchewan gaming facility, are not Qualified Entrants and are not eligible to win a Prize.

Qualified Entry

10. 12. "No-Purchase Necessary": Qualified Entrants may obtain one (1) Qualified Entry by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Sponsorship. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone number and email address. Only one (1) No-Purchase Necessary entry may be submitted per person in this Contest. Any mailing containing more than one entry, including multiple mail-ins by the same person, will be discarded, including any otherwise valid entry. Mail-in entries must be received by the close of the Contest Period in order to be eligible for a Prize.



The Prizes

- 13. There are a total of twenty prizes (each a "Prize") available to be won in this contest:
 - a) In British Columbia, ten (10) cash Prizes of \$1,000 are available to be won, to be deposited to the Prize Winner's PlayNow.com Account.
 - b) In Saskatchewan, ten (10) cash Prizes of \$5,000 are available to be won, to be deposited to the Prize Winner's PlayNow.com Account.
- 14. The Prizes cannot be transferred without the consent of BCLC, or SIGA in conjunction with BCLC, which may be withheld for any reason.

The Draw

- 15. Qualified Entries received with respect to each province during the Contest Period are entered into a random draw for that province (the "**Prize Draw**") to select 10 Qualified Entrants per province to win a Prize (the Drawn Entrants"). In British Columbia, the Prize Draw will occur on November 10, 2023 or as soon as practical thereafter. In Saskatchewan, the Prize Draw will occur on December 20, 2023 or as soon as practical thereafter.
- 16. A BCLC representative will attempt to contact the winner by telephone and/or email using the contact information provided in their PlayNow.com profile within five (5) days of a Prize Draw. It is the responsibility of each Qualified Entrant to ensure that their PlayNow.com account has current information, including a current telephone number and email address at which they can be contacted.
- 17.
