



Trick or Treat Surprise & 1 Year Birthday Surprise – Token Conditions

Definitions

BCLC means British Columbia Lottery Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Free Play means a token that may be used to wager on Eligible Games.

Drawn Entrant means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

Eligible Games means:

For British Columbia:

- PlayNow.com casino slot games, excluding live casino, subject to availability.

For Saskatchewan:

- All PlayNow.com casino games, excluding live casino, subject to availability.

Held Funds means the account where a player's winnings from a Token with a wagering requirement in progress are held.

Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not a:
 - BCLC employee; or
 - Family or household member of a BCLC employee, or
- a Saskatchewan resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not:
 - A SIGA or SaskGaming employee; or
 - An immediate family member of a SIGA or SaskGaming employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee.

Promotion Period means:

For British Columbia:

- The Promotion Period is from 00:00:00 am PT on Monday, October 16, 2023 to 23:59:59 pm PT on Sunday, November 5, 2023.

For Saskatchewan:

- The Promotion Period is from 1:00:00 am CST on Wednesday, November 15, 2023 to 11:59:59 pm CST on Wednesday, December 6, 2023.

Sports Freebet means a token that may be used to wager on Playnow.com Sports.

Token means a Casino Free Play or a Sports Freebet, or both.

Wagering Requirement means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Free Play.

How to Receive a Trick or Treat Surprise and 1 Year Birthday Surprise Token

1. To receive a Casino Free Play or Sports Freebet under this Promotion, you must complete the following steps, in the following order:
 - a. Register for an account on PlayNow.com or log into your PlayNow.com account.
 - b. Enter the “**Promotion Code**” that corresponds during the applicable “**Validity Period**”, as set out in the table below, in the “My Promotions” section of PlayNow.com.

There is a maximum of \$35 awarded in Casino Free Play and \$10 in Sports Freebets.

- c. A Promotion Code entered for a period before or after the Validity Period will not be eligible for a Token.
2. Each Promotion Code may only be redeemed once.
3. Once credited to your account, the Token must be used within 14 days. Tokens will not be reissued following expiration.

4. In British Columbia, each Casino Free Play awarded from this Promotion have a 30x Wagering Requirement applied to them.

Wagering Requirement Rules

In British Columbia,

- a. The Wagering Requirement for each Casino Free Play is thirty (30) times the value of redeemed Casino Free Play. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Free Play add up to thirty (30) times the value of the Casino Free Play .
 - i. For example, for a \$10 Casino Free Play , the Wagering Requirement = $\$10 \times 30 = \300 (\$10 Token + \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Token and \$290 of winnings from that original Token on eligible games.
 - b. Until the Wagering Requirement is met, any winnings generated from the Token will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
 - c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

5. In Saskatchewan, Casino Free Play awarded from this Promotion do not have Wagering Requirements.
6. See the PlayNow.com Player Agreement for terms and conditions applicable to Tokens.
7. An Eligible Participant may receive a maximum of one (1) Casino Free Play or one (1) Sports Freebet during each Validity Period.
8. Once credited to your account, the Casino Free Play and Sports Freebets must be used within 14 days. Tokens will not be reissued following expiration.
9. Casino Free Play awarded through this Promotion may only be used for wagering on Eligible Games.
10. Wagers placed using a Token do not qualify for any other promotion on PlayNow.com.
